

#### MCHHS Service Equity Assessment Partner Survey - Analysis

We received 95 completed surveys from partners; defined as at least 75% of the survey questions having been answered.

The top three types of agencies to respond were public agencies (31%), community-based organizations (26%), and adult foster care facilities (20%). Other agency types included health system/CCOs and mental health care providers.




Respondents were asked if their organization had a specific population focus; they were able to select all that applied. One respondent did not reply, and 15 indicated that their organization did not have a specific population focus. Of the 79 respondents that did answer this question, three quarters selected physical and/or mental disabilities. Nearly half selected youth and low income. "Other" includes mental health and addictions and justice involved.



The Table XX, below, displays how long survey respondents have worked with MCHHS. Half of all respondents have worked with MCHHS for over 5 years. Figure XX displays what the relationship between the organization and MCHHS primarily consists of. Four respondents did not answer this question. "Other" includes care coordination, being licensed by MCHHS, and oversight provided by MCHHS.







Respondents were asked to share what they thought were the top five unevenly and unfairly distributed health and quality of life issues in their community. Responses equal more than 100% as people provided more than one issue. Some of the other responses included:

- Access to community activities for youth
- Access to physical activity resources (such as parks, bike lanes, sidewalks)
- Access to the political process
- Child abuse/neglect
- Foster care
- Long term Medicaid waivered employment services for people with traumatic brain injuries and mental health
- Sexual health
- Peer social group supports
- Community Inclusion
- Social exclusion
- Criminal history
- Family conflict




Survey respondents were asked to answer a series of questions related to the awareness in MCHHS with respect to inequities. Figure XX displays their responses.






The next two questions examined what roles community leaders and government agencies play in MCHHS program and service planning and delivery.


In your experience, what role(s) do <u>leaders from the community in</u>

The final set of questions explore ways that MCHHS provides information and builds capacity of community members/organizations.




Organization type was split into four categories based on number of respondents:

- Other (n=21)




MCHHS, as an organization, demonstrates a commitment to addressing the environmental, social, and economic conditions that impact inequities. By type of organization.




MCHHS staff members that I have worked with demonstrate a commitment to addressing the environmental, social, and economic conditions that impact inequities. By type of organization.




MCHHS staff members that I have interacted with are familiar with the strengths and resources of residents and community institutions. By type of organization.






#### MCHHS values input from community residents. By type of organization.




#### MCHHS values input from organizations like mine. By type of organization.






