

Theory of change strategies and activities

Where we landed last week

Across both groups:

- Consensus on moving forward with strategy 5 as is
- Some minor feedback and proposed revisions to strategies 1, 2, and 6 that we are working to incorporate
- Desire for more discussion as a full group about strategies
 3 and 4

Strategy 3

3. Identify and assess community priorities

- a. CBOs collect data to identify community needs, assets, and priorities
- b. OHA provides training to CBOs on community data collection
- c. OHA provides TA and support for collecting, storing, and analyzing data
- d. OHA provides various levels of data collection requirements and associated funding amounts for CBOs based on capacity
- e. OHA provides additional funding for CBOs who are providing interpretation/translation data into and from languages other than English
- f. CBOs engage community members in data interpretation
- g. CBOs communicate assessment results and priorities to OHA and their community members
- h. OHA and CBOs collaborate to disseminate and report assessment results

Feedback:

- Some activities can be combined
- OHA should provide the interpretation and translation services (e)
- OHA needs to compile, integrate, standardize, and report back data from CBOs (g, h)
- Activities seem top-heavy

Strategy 4

- Provide culturally and community -specific, proactive, and responsive education and communication
- a. CBOs build and expand community relationships and trust
- b. CBOs tailor information to meet the needs of communities they serve (culturally, linguistically, geographically, etc.)
- c. CBOs share information with community members they serve in accessible, proactive, and responsive ways
- d. OHA provides TA and support on developing communications such as creating videos and designing social media posts
- e. CBOs collaborate and share lessons learned and successful strategies

Feedback:

- Consider how the support needed by different CBOs varies (e.g., some will need content expertise from OHA, others won't)
- OHA can facilitate spaces for CBOs to come together for peer learning (e)
- Unclear what information/education is being shared
- TA support needs to be a broader menu than these examples (d)
